PRO-INSTALL™	This Mark is pending registration. This Mark must be in all caps, one separate word, followed by the ™ symbol.

AJS®	This Mark has been registered. This Mark must be in all caps, one word, and followed by ® symbol.
ALLJOIST®	This Mark has been registered. This Mark must be in all caps, one word, and followed by ® symbol.
ANCHOR™	This Mark is a common law mark. This Mark must be in all caps, one word, followed by the ™ symbol.
BC CALC®	This Mark has been registered. This Mark must be in all caps, two words, and followed by ® symbol.
BC COLUMN®	This Mark has been registered. This mark must be in all caps, two separate words, followed by the ™ symbol.
BC CONNECT™	This Mark is pending registration. This Mark must be in all caps, two separate words, followed by ™ symbol.
BC ESTIMATOR®	This Mark has been registered. This Mark must be in all caps, two separate words, followed by the ® symbol.

BC FRAMER®	This Mark has been registered. This Mark must be in all caps, two words, and followed by ® symbol.
BC RIM BOARD™	This Mark is a common law mark. This Mark must be in all caps, three separate words, followed by ™ symbol.
BC TRACKER®	This Mark has been registered. This Mark must be in all caps, two separate words, followed by ® symbol.
BCI®	This Mark has been registered. This Mark must be in all caps, one word, and followed by ® symbol.
BOISE EVERGREEN™	This Mark is a common law mark. This Mark must be in all caps, two words, followed by the TM symbol
BOISE FloorTek™	This Mark is a common law mark. This Mark must be two separate words, the first word in all caps and the second word with a cap on "Floor" and "Tek" and followed by the ™ symbol.
BOISE FrameMark™	This Mark is a common law mark. This Mark must be two separate words, the first word in all caps and the second word with a cap on "Frame" and "Mark" and followed by the ™ symbol.
BOISE GLULAM®	This Mark has been registered. This Mark must be in all caps, two words, and followed by ® symbol.
BOISE GOLD®	This Mark has been registered. This Mark must be in all caps, two words, and followed by ® symbol.
BOISE PlansRoom™	This Mark is a common law mark. This Mark must be two separate words, the first word in all caps and the second word with a cap on "Plans" and "Room" and followed by the ™ symbol.
BOISE PROCESS CONTROL FRAMING™	This Mark is pending registration. This Mark must be in all caps, four words, followed by the ™ symbol.
BOISE QuickQuote™	This Mark is a common law mark. This Mark must be two separate words, the first word in all caps and the second word with a cap on "Quick" and "Quote" and followed by the ™ symbol
BOISE SELECT®	This Mark has been registered. This Mark must be in all caps, two separate words, followed by the ® symbol.
BOISE TOOL KIT™	This Mark is a common law mark. This Mark must be in all caps, three separate words, followed by the TM symbol.
BOISE TOTAL QUALITY BUILDING™ (w/o register)	This Mark is a common law mark. This Mark must be in all caps, four separate words, followed by the TM symbol.
BOISE TQBuild®	This Mark has been registered. This mark must be two separate words, the first word in all caps and the second word with a cap on "TQ" and "Build" and followed by the ® symbol
CASCADE CREST®	This Mark has been registered. This Mark must be in all caps, two words, and followed by ® symbol.
CUSTOM-I™	This Mark is a common law mark. This Mark must be in all caps, one hyphenated word, followed by the TM symbol.
DIXIE JOISTS™	This Mark is a common law mark. This Mark must be in all caps, two words, followed by the TM symbol.
FILLER KING™	This Mark is pending registration. This Mark must be in all caps, two words, followed by the TM symbol
FILLER KING LAMINATED DECKING™	This Mark is a common law mark. This Mark must be in all caps, four separate words, followed by the TM symbol.
For the business of Engineered Wood Products.™	This Mark is a common law mark. This Mark must be separated words in a sentence form, beginning cap on the words "For", "Engineered", "Wood", and "Products" only, and followed by a period and the TM symbol
Great products are only the beginning.®	This Mark/Tagline has been registered. This Mark must be separated words in a sentence form, beginning cap on "Great" only, and followed by a period and the ® symbol
Green products for over 50 years.™	This Mark/Tagline is a common law mark. This Mark must be separate words in sentence form, beginning cap on "Green" only, and followed by a period and the TM symbol.

HOLES-N-I™	This Mark is a common law mark. This Mark must be in all caps, hyphen between words, followed by the TM symbol.
KING BEAM™	This Mark is pending registration. This Mark must be in all caps, two words, followed by the TM symbol
KINZUA™	This Mark is a common law mark. This Mark must be in all caps, on word, and followed by the TM symbol.
 KINZUA™ (KINZUA Design)	This Mark Design is a common law mark. This Design must appear as shown, and followed by the TM symbol. To request use of this Design, contact Boise Cascade's Legal Dept - 208/384-4925.
POST-N-BEAM™	This mark is a common law mark. The Mark must be in all caps, with hyphens on each side of the letter N, followed by the TM symbol.
SawTek™	This Mark is a common law mark.. This Mark must be one word, with a cap at "Saw" and "Tek", followed by the TM symbol.
SIMPLE FRAMING SYSTEM®	This Mark must be in all caps, three words, and followed by ® symbol.
SUPER SHELF®	This Mark has been registered. This Mark must be in all caps, two words, and followed by ® symbol.
SUPER STEP®	This Mark has been registered. This Mark must be in all caps, two words, and followed by ® symbol.
TQStructure®	This Mark has been registered. This Mark must a separate abbreviation and word, the first abbreviation must be in all caps and the second word with a cap on Structure and followed by the ® symbol.
TRU-FORM®	This Mark has been registered. This Mark must be in all caps, two hyphenated words, and followed by ® symbol.
TRU-PLY®	This Mark has been registered. This Mark must be in all caps, two hyphenated words, and followed by ® symbol.
VERSA-DECK™	This Mark is a common law mark. This Mark must be in all caps, two words, followed by the TM symbol
VERSA-FLOOR™	This Mark is a common law mark. This Mark must be in all caps, hyphen between words, followed by the TM symbol.
VERSA-LAM®	This Mark has been registered. This Mark must be in all caps, two hyphenated words, and followed by ® symbol. This Mark has been registered.
VERSA-LAM PLUS®	This Mark must be in all caps, three words, hyphen between first two words, and followed by ® symbol.
VERSA-RIM®	This Mark has been registered. This Mark must be in all caps, two hyphenated words, and followed by ® symbol.
VERSA-SAW™	This Mark is a common law mark. This Mark must be in all caps, hyphen between words, followed by the TM symbol.
VERSA-STRAND®	This Mark has been registered. This Mark must be in all caps, two hyphenated words, and followed by ® symbol.
VERSA-STUD®	This Mark has been registered. This Mark must be in all caps, two hyphenated words, and followed by ® symbol.
