

Registrar's Report

To the Board of Directors and Management of Boise Cascade, L.L.C.

We have audited management's assertion, set out in the attached letter, that Boise Cascade, L.L.C. has met the requirements of the Sustainable Forestry Initiative[®] Program (SFI) Annex 2 Chain of Custody Standard (October 2006) and the Programme for the Endorsement of Forest Certification Schemes (PEFC) Annex 4: Chain of Custody of Forest Based Products – Requirements Standard (June 17, 2005) ("the Standards") at the White City veneer manufacturing facility¹ as of November 24, 2006.

Management is responsible for ensuring the White City veneer manufacturing facility met these requirements. Our responsibility is to express an opinion on management's assertion that the White City veneer manufacturing facility met these requirements, based on our audit. The requirements of the SFI[®] and PEFC Chain of Custody Standards can be found at www.aboutsfb.org and www.pefc.org.

Our audit was conducted in accordance with the ISO 19011:2002 Management System Auditing Standard and, accordingly, included examining, on a sample basis, evidence supporting management's assertion that the White City veneer manufacturing facility met the requirements of the Standards, evaluating on an overall basis whether the requirements were met, and performing such other procedures as we considered necessary in the circumstances. Our tests of the operating effectiveness of the specific controls were as of November 28, 2006. The projection of any conclusions, based on our findings, to future periods is subject to the risk that changes may alter the validity of such conclusions. We planned and performed our work in order to obtain reasonable, rather than absolute, assurance with respect to the information examined. We believe our examination provides a reasonable basis for our opinion.

In our opinion, the Chain of Custody management system and control procedures for the White City veneer manufacturing facility were suitably designed to provide reasonable assurance that the requirements of the Standards were met, in all material respects, and that the management system and control procedures operated effectively as of November 24, 2006.
