Re: Renewed Notice Requirements of Consumer Products under California  
Proposition 65

Dear Customer:

This letter is to update you on warning requirements for raw wood products pursuant to the California Health and Safety Code Section 25249.5 et seq., commonly referred to as Proposition 65 ("Prop 65"). On August 30, 2018, modifications to certain Prop 65 warnings and compliance requirements went into effect that require updates to the notice to consumers as described below.

According to Prop 65, no person in the course of doing business in California shall knowingly and intentionally expose individuals to wood dust from raw wood products without first providing a clear and reasonable warning. As a manufacturer of raw wood products, Boise Cascade Wood Products, L.L.C. ("Boise Cascade") is required to provide written notice to you that the raw wood products supplied by Boise Cascade could expose individuals to wood dust when such products are drilled, sawed, sanded, machined, or otherwise handled in a manner that will produce wood dust. Boise Cascade provides the following warning:

**Warning:** Drilling, sawing, sanding or machining wood products can expose you to wood dust, a substance known to the State of California to cause cancer. Avoid inhaling wood dust or use a dust mask or other safeguards for personal protection. For more information go to [www.P65warnings.ca.gov/wood](http://www.P65warnings.ca.gov/wood).

Due to the nature of your business, you are also required to comply with the Prop 65 warning requirements. Retail sellers are required to post a warning sign in compliance with Prop 65, which requires displaying the warning "either at the point of sale or display of the wood products in a manner likely to be seen by the purchaser." The notice or sign must be no smaller than 8 1/2 by 11 inches and printed in no smaller than 20-point type. §25607.10.

A copy of a ready-to-post warning sign is included for your use and the use of your customers in compliance with Prop 65. Additional copies are available from Boise Cascade at 1111 W. Pursuant to Prop 65, the retail seller is responsible for the placement and maintenance of the warning sign, and Boise Cascade expects you to ensure that proper notice of the warning sign is conveyed to your customers. Boise Cascade will hold you responsible, in accordance with our Terms & Conditions located at <http://www.bc.com/terms-conditions/sales-terms-and-conditions>, for any failure to properly convey the warning sign provided to you.
