Re: Renewed Notice Requirements of Consumer Products under California Proposition 65

Dear Valued Customer:

This letter is to update you on warning requirements for the product categories listed in the attached product spreadsheet pursuant to the California Health and Safety Code Section 25249.5 et seq., commonly referred to as Proposition 65 ("Prop 65"). On August 30, 2018, modifications to certain Prop 65 warnings and compliance requirements went into effect that require updates to the notice to consumers as described below.

According to Prop 65, no person in the course of doing business in California shall knowingly and intentionally expose individuals to chemicals known to the State of California to cause cancer, and chemicals known to the State of California to cause birth defects or other reproductive harm. The attached spreadsheet lists a variety of products distributed by Boise Cascade Building Materials Distribution, L.L.C. ("Boise Cascade Building Materials Distribution") and the chemicals contained within them that meet the threshold level for Prop 65. As your supplier, we are alerting you to this requirement to ensure your ongoing compliance.

Due to the nature of your business, you are also required to comply with the Prop 65 warning requirements. Retail sellers are required to post a warning sign in compliance with Prop 65, which requires displaying the warning "either at the point of sale or display of the wood products in a manner likely to be seen by the purchaser" (§25607.10) or, for products other than wood products, displaying the warning "on a posted sign, shelf tag, or shelf sign for the consumer product at each point of display of the product" (§25602). The notice or sign must be no smaller than 8 1/2 by 11 inches and printed in no smaller than 20-point type. (§25607.10). If you have customers that order products via the internet or by phone, you are required to provide the Prop 65 warning in an appropriate manner. Products distributed by Boise Cascade Building Materials Distribution that require a warning are listed in the attached Product List, which describes the type or types of warnings required to be displayed.
