

Trademark License Agreement

Thank you for your business and continued interest in Boise Cascade. We value your company and the continuing relationship between our companies. Boise Cascade's trademark policy is to carefully and explicitly protect its trademark rights by requiring third parties to agree to certain terms and conditions, as listed in the Trademark License Agreement below, before being authorized to use Boise Cascade trademark(s). Boise Cascade's trademarks are valuable company assets that have been built through considerable time and expense. They tell consumers that a product or service comes from or is endorsed by Boise Cascade. Boise Cascade wants to ensure that the use of its trademarks is consistent with Boise Cascade's trademark standards, provides distinct ownership by Boise Cascade, and is reflective of Boise Cascade's values and reputation.

Trademark License Agreement

1.0 Boise Cascade Company and its affiliates ("Boise Cascade") are the sole and exclusive owners of the trademarks listed on Exhibit A, attached to this Agreement. The licensee acknowledges and agrees that Boise Cascade retains all right, title, and interest in and to the Marks, and that any and all goodwill arising from the use of the Marks shall inure solely to the benefit of Boise Cascade.

2.0 Boise Cascade shall have complete discretion in determining whether to grant or deny the licensee's request for a cancelable nonexclusive, nontransferable, non-sublicensable license to use the Mark(s) indicated on Exhibit A and submitted with this Agreement. If Boise Cascade determines, in its sole discretion, to grant the requested license, it shall do so for a period of one year, commencing on the date that Boise Cascade provides written confirmation of such grant to the licensee.

3.0 You agree to:

3.1 Use "Boise Cascade" when referring to the company as a whole.

3.2 Use the Mark in strict conformance with Boise Cascade's Trademark Guidelines and Branding Guidelines. Any deviation from these guidelines without the express prior written consent of Boise Cascade shall constitute a breach of this Agreement.

3.3 Submit a sample of your proposed usage of the Mark in advance for pre-approval by Boise Cascade. Upon approval, Boise Cascade will return a fully executed copy of the one-year Trademark License Agreement to you. You agree to allow Boise Cascade to periodically monitor your use of the Mark to ensure strict compliance with the terms of this Agreement.

3.4 Cooperate with Boise Cascade in ensuring that your use of the Mark conforms to Boise Cascade's Trademark and Copyright Guidelines, in addition to Boise Cascade's quality standards applying to the Mark, and facilitate Boise Cascade's control of the nature and quality of goods and services rendered by you in connection with the Mark.

3.5 Include with any publication (online or in print) of the Mark, a trademark legend stating, for example, "BOISE CASCADE, BC Calc, and BCI are trademarks of Boise Cascade Company, or its affiliates" or "BOISE CASCADE is a trademark of Boise Cascade Company, or its affiliates".

3.6 Indemnify and hold Boise Cascade harmless for any and all costs, fees, and expenses (including reasonable attorney's fees) from any third-party claims that may arise as a result of the licensee's use of the Mark, including claims that the licensee's use of the Mark violates any applicable laws or regulations or any right of or duty owed to any person or entity. This shall not be interpreted to mean that Boise Cascade in any manner warrants to you that the Mark is valid or that your use of the Mark will not infringe the rights of others. **BOISE CASCADE MAKES NO WARRANTIES OF ANY KIND.**

4.0 You will not:

4.1 Add to or modify the Mark in any way;

4.2 Use the Mark to benefit any third-party's products or services;

4.3 Disparage Boise Cascade or its products or services in any way;

4.4 Sell any Boise Cascade logo marked product to anyone other than Boise Cascade Company or its affiliates or approved customers. However, resellers who have purchased goods with the Boise Cascade Marks are permitted to sell these goods subject to the condition that the reseller does not alter, obscure or remove the Boise Cascade Marks. Resellers are also permitted to use the Boise Cascade Marks for the sole purpose of advertising and promoting the products; or

4.5 Encourage unlawful activities by others in an unlawful manner.

5.0 Boise Cascade may terminate this license at any time for any reason. Upon receipt of Boise Cascade's written termination notice, you agree to immediately discontinue your use of the Mark. Notice shall be delivered to the physical address or email address provided in Section 14 and is considered to be received three days after Boise Cascade mails such notice, or immediately upon sending such notice in an email, whichever Boise Cascade chooses.

6.0 Upon completing the requested information in this Trademark License Agreement and emailing it to Boise Cascade, you agree that you are hereby authorized to execute this Agreement on behalf of the Organization listed below and that said Organization agrees to comply with the terms of Boise Cascade's Trademark License Agreement, as set forth herein. The licensee further acknowledges that any breach of this Agreement may cause irreparable harm to Boise Cascade for which monetary damages may not be an adequate remedy, and therefore, Boise Cascade shall be entitled to seek injunctive relief, in addition to any other available remedies, without the need to post a bond or prove actual damages.

7.0 Nothing in this Agreement shall be construed as a waiver or limitation of any of Boise Cascade's rights or remedies under applicable laws, including but not limited to, trademark infringement, unfair competition, and common law trademark rights.

8.0 This Agreement represents the entire agreement between the parties, and supersedes all prior understandings or agreements, whether written or oral, regarding the subject matter of this Agreement. Any amendment to this Agreement shall be in writing.

9.0 This Agreement shall be governed by and construed in accordance with the laws of the state of Idaho, without giving effect to any principles of conflicts of law. Any dispute arising out of or relating to this Agreement shall be resolved through binding arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.

10.0 If any provision of this Agreement is held to be unenforceable, the remaining provisions shall remain in full force and effect.

11.0 This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
